- 2) Teams may have to play up one year in order to fill out brackets. Teams may not withdraw from the tournament if they are moved up.
- 3) Once bracketing has begun, teams withdrawing from the tournament for any reason may incur a \$500.00 fine to their association. **DO NOT ENTER THE TOURNAMENT IF YOU ARE NOT PLANNING ON PLAYING!!**
